The main objective of the business promotion mission is to facilitate the establishment of business contacts with potential business partners and explore emerging opportunities for joint ventures/technology transfers between Sri Lanka and Indonesia.

Indonesia and Sri Lanka launched the negotiations for a Preferential Trade Agreement (PTA) in March 2024.

Sri Lanka is an important partner to Indonesia in the Southeast Asian region. The PTA negotiations are expected to enhance market access, boost economic growth, and become the first step towards an Free Trade Agreement (FTA).

A PTA typically reduces or eliminates tariffs on selected goods, making it the first step in economic integration.
